CONSENT INTERLOCUTORY JUDGMENT OF JUDGE KATHRYN BECK

(Application for stay of execution)

[1] On 22 December 2023, the Employment Relations Authority ordered that JRL Culture Media Ltd (JRL) pay Changyong Zhang costs and disbursements of

\$9,571.55.1

[2] JRL has challenged that determination and, seeking to preserve its position, has applied for a stay of execution.

[3] The application proposes that the amount of \$9,571.55 be paid to the Registrar of this Court, to be held in an interest-bearing account until further order of the Court.
