INTERLOCUTORY JUDGMENT OF JUDGE K G SMITH

**(Application for continuation of freezing order)**

LISA KINGIPOTIKI v IAN MARK TAPLIN AND SOUTH TARANAKI TRUSTEES LIMITED AS TRUSTEES OF THE I M TAPLIN FARMING TRUST [\[2022\] NZEmpC 99](#) [7 June 2022]

[1] On 30 May 2022 I granted an application for a freezing order against the trustees of the I M Taplin Farming Trust.<sup>1</sup> That order was to have effect until 7 June 2022 unless on that date it was continued or renewed.

[2] On 3 June 2022 the parties filed a joint memorandum seeking by consent a continuation of the freezing order and further orders. An urgent hearing was convened with counsel that day.

[3] I am satisfied that counsel's proposal for the extension of the freezing order by consent is appropriate. After discussion with counsel I order as follows:

- (a) The freezing order granted on 30 May 2022 is continued until **4 August 2022** on which day it will lapse unless it is further continued.
- (b) Either party may apply on notice to revoke, alter or amend the freezing order prior to 4 August 2022.
- (c) Pending further order of the Court, the defendant is excused from filing a statement of defence.

(d) The parties are directed to attend urgent mediation.

[4] The freezing order application will be called at Christchurch at **10 am on 4 August 2022**. The hearing will be conducted by virtual meeting room or if that is not available for any reason by telephone.

[5] Costs are reserved.
