CONSENT JUDGMENT OF JUDGE KATHRYN BECK

[1] The parties have settled both proceedings and request that their agreement be recorded in a judgment by consent.

[2] By consent, I make the following orders:

MARK SINTON v COATESVILLE MOTORS 2013 LIMITED [\[2020\] NZEmpC 235](#) [18 December 2020]

EMPC 139/2020

(a) Mr Sinton will pay Coatesville Motors 2013 Limited (Coatesville) the sum of \$2,033 in respect of the Warrant of Fitness training course fee.

(b) Mr Sinton withdraws his challenge to the Employment Relation Authority's substantive determination.¹

(c) Mr Sinton will pay to Coatesville the sum of \$12,000 costs on his withdrawal of the proceeding.

EMPC 201/2020

(a) Coatesville's challenge to the Authority's costs determination is allowed.²

(b) The award of costs made against Mr Sinton in the Authority is increased by \$5,750 (to a total figure of \$8,000).

(c) Mr Sinton is to pay to Coatesville the sum of \$4,250 in costs on the challenge.
