

- [2] By way of a letter dated 15 February 2010, and attaching a joint memorandum signed off by the parties' advocates, Ms Chilwell advised they had agreed that costs of \$1,000 should be payable by the applicant to the respondent and that their agreement should be recorded in a consent determination.
- [3] I accept that request and hereby determine that the parties' agreement, as detailed above and per the attached, is incorporated into this consent determination.
- [4] The parties are to be commended for settling this matter on their own terms.
