[2] At a Judicial Settlement Conference held on 4 May 2016, all issues between the parties were resolved on a full and final basis.

[3] This judgment records the matters which the parties have agreed should be included in a consent judgment.

[4] Pursuant to [s 183\(2\)](#) of the [Employment Relations Act 2000](#) (the Act) and by consent, the determination of the Authority is set aside.

[5] Each party acknowledges that the other acted at all times in good faith.

[6] The remaining terms of settlement between the parties are set out in a confidential settlement agreement, which I direct is now the subject of an order of non-publication pursuant to cl 12(2) of Sch 3 of the Act.

[7] There are no issues as to costs.
