### INTERLOCUTORY JUDGMENT OF JUDGE K G SMITH

(Application for in-Court media coverage)

[1] An application has been made by NZME and Top South Media (NZ Herald and Nelson Weekly with possible syndication) to cover this proceeding which is being heard by audio visual link. The applicant proposes that recordings and photographs may be taken and used. Standard conditions are proposed.

[2] The application has been drawn to the attention of the plaintiff; no steps have been taken by the defendants.

TOVIO UGONE v STAR MOVING LIMITED [\[2023\] NZEmpC 127](#) [14 August 2023]

[3] No objection has been taken to the application.

[4] Court proceedings are generally open to the public and media. There are restrictions on filming and recording in Court; anyone wishing to do so must obtain prior judicial permission which involves the exercise of a broad discretion.

[5] The In-Court Media Guidelines 2016 have been developed to assist in exercising the discretion.<sup>1</sup> The key principle is promoting open justice, but other principles to be considered include the need for a fair hearing, recognising that the media has an important role in reporting on hearings to inform the public and the interests, reasonable concerns and perceptions of parties and witnesses.

[6] Weighing up those principles, I am satisfied it is appropriate to grant the application subject to the standard conditions. Orders are made accordingly.
